



Horses will be in the barns on Thursday, Friday, and Saturday as well.









## 2025 Lane County Fair Lawn Mower Race Rules

Wednesday, July 16 at 7:30 pm (grassy area south of arena)

- 1. All mowers must have blades, mower decks and baggers removed.
- Each driver must be 14 years or older with a valid driver's license. Farm permits accepted.
- 3. Driver must wear helmet and eye protection.
- 4. Driver must wear long sleeve shirt and long pants, as well as no open toed shoes.
- 5. Must have a device that will kill engine if you become separated from your mower.
- 6. If there is anything the officials deem unsafe to the operator or other contestants, your vehicle will not pass inspection. If the infractions are not repaired, up to the official's approval, prior to closing of the check in period, your vehicle will be disqualified.
- 7. Officials have final say.

## Stock Class Rules :

- 1. Must be factory lawnmower with no modifications to the engine.
- 2. Tires must be stock size, no aggressive tread. Up to official's discretion.
- 3. Must have lawn mower style seat.

Modified Class Rules :

- 1. Can use racing tires or more aggressive tire tread. Up to official's discretion.
- 2. Go cart seats allowed.
- 3. Allowed to run after-market parts and make modification to motor and rear of mower.

Entry Fee : \$25 Payout : \$100 1st Place \$50 2nd Place in each class



#### LANE COUNTY FAIRBOARD GENERAL RULES

- 1. During all exhibitions conducted by the Lane County Fairboard, the Fairboard shall have absolute authority, control and supervision of same.
- 2. The Fairboard, upon its own initiative, and/or upon complaint(s) presented to the Fairboard by a 4H Leader(s) or other interested parties may, within its discretion, by a majority of vote of a quorum of a properly called Fairboard meeting, make binding determination/rulings resulting in the ejection and/or disqualification of an Exhibitor and/or Exhibit.
- 3. Grounds for ejection/disqualification of an Exhibitor and/ or exhibit shall include, but not be limited to: Disruptive, un-sportsmanlike or other inappropriate behavior of an Exhibitor's parent(s), Guardian(s), or other representative(s); and lack of authenticity of an exhibit and all other reasonable grounds, all as determined by, and within the discretion of the Fairboard.



- 1. Exhibitors are expected to comply with all rules. Those failing to comply to the rules are subject to award cancellation and disqualification.
- 2. Only state fair blue and purple ribbons may enter state fair competition (See State Fair book).
- 3. ALL STATE FAIR ENTRIES WILL BE REVIEWED AND CHECKED THE WEEK FOLLOWING THE COUNTY FAIR. PLEASE COMPLETE STATAE FAIR ENTRIES IN THE KSF NOTEBOOK BEFORE THE CLOSE OF FAIR.
- 4. Anyone interfering with a judge's decision will automatically disqualify the entry in question. Judges comments shall be placed on entry cards.
- 5. All members must own project. Members may exhibit only items for projects in which they are enrolled.
- 6. The 4H Building will be open to view the exhibits as follows: Wednesday, 3:00—9:00 pm, Thursday and Friday from 9:00am—9:00 pm and Saturday 9:00am to 7:00pm The building will be closed during judging on Wednesday and Friday, during the parade.
- 7. Except for booths, and cookie jars, classes will be rated on a point system. At the end of the fair, the total points by all 4H members will be divided into the total prize money and the value of each point will be determined and each contestant's premium check will be figured accordingly. Premium will include: Horse, Poultry & Rabbits. No Livestock (Beef, Sheep, Swine, and Goats).

- 8. Judging will be done by age not experience in all projects.
- 9. Cards with colored stickers will be given out during the fair rather than ribbons. These can be redeemed at the Extension office for ribbons for those who request them. Grand Champion and Reserve Grand Champion ribbons will still be given out and displayed at the fair.
- 10. Any exhibit that is brought in for judging, but the exhibitor chooses not to have it displayed, will receive only a ribbon award but no premium.
- 11. **All** classes will be divided in Junior and Senior as stated by the Class number followed by "**A**" for Junior or "**B**" for Senior.
- 12. If a child is not available for consultation judging parents can bring projects in but will not be allowed to answer questions or be present for judging. Superintendent will be available to write comments.
- 13. 4-H & FFA members must meet the member in good standings requirements to participate in food and live-stock sale.
- 14. Copyrighted and/or trademarked materials used in displays, demonstrations, posters or other activities will be disqualified if the exhibitor does not request permission to use the copyrighted and/or trademarked materials and will not be displayed or receive ribbons.

#### APPEALS

#### Lane County Fair Appeal Committee Members

- Lane Co. 4H Council will select 3 members that represent all the 4H Clubs
- Lane Co. Fairboard will select one member.

#### **Purpose of Committee**

All issues will be handled as normal during the fair. The steps will be the superintendent first and then the agent. The superintendent and agent have the option to discuss issue with the appropriate fair committee. The Appeal Committee will discus issues that have not been resolved by the appropriate superintendent and/or agent's this committee's decision will be final.

#### **Guidelines for the Committee**

- 1. The committee will need to have the issue presented to them in writing.
- 2. This appeal process can not stop any planned fair activity. The committee will need to have time to allow the members to get together.
- 3. If a member or members of the committee are involved in the issue, then the clubs will need to find/appoint another representative.
- 4. The committee will base decisions on guidelines of rules pertaining to the area of the fair. Information that has been sent or given to all families and the committee will need to visit parties involved.
- 5. Depending on the issue or the timing, the committee's decision may not have an effect on this year's fair.
- 6. This committee needs to realize that their decision will affect all 4H members.


15. Cloverbuds can do Cookie Jars but will not be eligible for a grand or reserve prize. The jars can sell but money will go to 4H Council.

#### LIVESTOCK

- a. 4-H members must show their own 4H livestock in showmanship.
- b. A grand and reserve grand will be chosen in junior and Senior showmanship.
- c. All exhibitors must show their own animals unless they have two animals in the same class, then another Lane Co. 4H member can assist.
- c. All livestock members that are showing breeding or market animals, or plan to have animals as part of the livestock premium sale, will need to complete and age appropriate YQCA(Youth for the Quality Care of Animals) class either in person or online before July 1st of the current year.
- d. All animals are subject to examination by the Exhibition staff or their representatives and shall be free of clinical signs of infectious or contagious disease.
- e. Feed and bedding for livestock will be furnished by the exhibitor.
- f. Stall cards must be displayed with all animals.
- g. The livestock fund will only be used to compensate for livestock that dies at the Lane County Fair.
- h. Average daily gain, total gain and cost of gain will be computed on each marketing animal on display. Please note that each exhibitor is responsible for card display during the fair.
- i. Under Kansas Law, there is no liability for an injury to or death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to Section 1 through 4 of KSA 60-208. You are assuming the risk of participating in this domestic animal activity.

BEEF — Justin & Chelsey Shapland; Jarret Shapland

- a. Calves must be permanently tagged and weighed by Extension staff at least 120 days prior to the fair at the official weigh in.
- b. Heifer and breed cows shown in breed classes must have a copy of their registration papers turned into the Extension office by May 1. Registrations must be in the 4-Hers name or family name.
- c. Classes will be divided at the discretion of the beef committee.
- d. No intact males over one (1) year of age may be shown.
- e. Market beef not weighed in at weigh-in will not be eligible for the rate of gain award.
- f. No water or feed tubs are to be left unattended in the stalls in the beef barn.
- g. Animals must be tied in the barn from noon to 9:00 p.m.
- h. All show cattle will be broke to lead and manageable. If the beef committee determines they are not manageable they are to be removed from the grounds and will not be sold through the premium sale. This will be at the discretion of the beef committee.
- i. The 1st and 2nd blue ribbon placing of each class are eligible to compete for breed champion and reserve grand champion.
- j. Cattle determined by exhibition staff to have lesions of

#### **Commercial Beef Feeding Project**

- k. Four calves may be tagged, but only three shown at the fair.
- 1. Calves must be quiet and manageable subject to the discretion of the beef committee.
- m. Calves will be weighed in at the regular weigh-in 120 days prior to the fair. Must be fed at home, not a commercial feedlot.
- n. Judged on: Rate of Gain Interview Live Appearance Carcass
- These calves will not sell in the premium auction. There 0. will be added premium money for this project.

#### **Bucket Calf**



- a. The sheep committee has the right to combine classes to make the show more efficient.
- b. At the time of showing, all market lambs must be slick shorn with an even length of wool covering above the hock and knee (head excluded).
- c. Sheep must be identified with an official USDA premises ID Tag (Scrapie Tag).
- d. Sheep must be free of clinical signs of active fungal (ringworm) infection, including club lamb fungus and sore mouth
- e. Market sheep must weigh at least 90 pounds. Those below 90 pounds may still be shown but will NOT be eligible for overall champion or reserve champion honors.

#### HORSE – Katie & Bella Riffle

- a. Follow rules in KS 4H Horse Show and Events book.
- b. 4H members must manage (management includes: feeding, grooming, exercising, training, stall management, etc.) and have access to the horse at least 75% of the year.
- c. Identification certificates required on all horses. Paperwork must be turned into Extension office by June 1.
- d. The age of a colt is determined as of January 1 in the year a colt is born, irrespective of what month the colt is born.
- e. Age of exhibitor is determined as of January 1 of the current year.
- f. Stallions may be shown only as weanlings.
- g. If working colts in the show ring, the colt must be exhibited by a 4H member, one attendant of 4H age may help.
- h. Any exhibitor who does not abide by fair rules will forfeit all premium ribbons or prize money.
- i. Riders shall wear Western hat, long-sleeved shirts, trousers and western boots. The use of gloves, ties, spurs and chaps shall be optional. The use of protective gear, in place of a hat, is the optional choice of the exhibitor. Western saddle and bridle are required. Tapaderos are prohibited. Horses will be ridden with a snaffle, curb, spade, half-breed bit or with a rawhide leather or rope hackamore (bosal). Bosals or nosebands are not permitted with a bit. Silver or fancy equipment will not count over good, clean, working equipment. Spurs should be dull-ended or free rowel moving. Any horse 56 inches (without shoes) and under may show in pony pleasure. If you show in pony pleasure you cannot show in another western pleasure class. All ponies in question will be measured at check-in area at all district shows. Their height will be put on the I.D. papers for the state show.

- k. Champion mare and gelding will be chosen from the top two blues in each halter class.
- l. Grand and reserve grand champion ribbons will be giv en to the over all top two mares and top two geldings.
- m. A comprehensive vaccination protocol is recommended, but not required by KDAH.
- n. Kansas Origin Horses—A valid VS Form 10-111 showing evidence of a negative Equine Infectious Anemia (Coggins) test conducted by a state-approved laboratory within 12 months prior to exhibition is recommended, but not required by KDAH.
- o. Halters and ropes will not be left hanging on gates.
- p. 2 year old Snaffle Bit Western Pleasure project and class is only for 14 years old and up that have filed a nomina tion I.D. certificate by May 1.
- q. An all around award will be given to the high point and reserve high point exhibitor in each age division.

#### POINTS

- 1. Point earning classes are 54, 62-63, 66-74.
- 2. Points will be accumulated on individual rider
- 3. Points will be determined by number of contestants in the class, with a maximum of 4 points for the class winner. Example: there are 3 riders in a reining class. First place = 3 points, Second place = 2 points, Third place = 1 point.
- If there are 4 or more riders to a class, points will be: 1<sup>st</sup> = 4; 2<sup>nd</sup> = 3; 3<sup>rd</sup> = 2; 4<sup>th</sup> = 1.

#### 4H LIVESTOCK SALE (Premium Only)

The 4H Livestock Sale will be Saturday at <u>5:00 p.m.</u> at the Livestock Show Barn

- 1. Market Sheep Minimum weight 90 pounds
- 2. Market Beef Minimum weight 1000 pounds
- 3. Market Heifers- Minimum weight 950 pounds
- 4. Market Hogs Minimum weight 200 pounds

- a. **All livestock** regardless of weight can be shown at the fair. However, the animals must meet the minimum weight requirement to be eligible for premium bid auction.
- b. All 4-H members must enter the showmanship contest with an animal in a division they exhibited to be eligible for sale, except poultry.
- c. A maximum total of three (3) animals or pens of poultry and rabbits may be sold at the livestock auction with a maximum of two (2) animals per species.
- d. Buyers will bid a premium only on all livestock. This will be on a dollar/per head basis. The price bid is the full price paid. If a buyer wants to purchase an animal for butcher, they must make the agreement directly with the 4H member.
- e. Only market animals will run through the sale
- f. 4-H & FFA members must meet the member in good standings requirements to participate in Livestock sale.
- g. All livestock run through the 4-H Livestock Sale fund will have a 2% commission withheld from all animals.
- h. 4H member must turn in stamped thank you notes addressed to the buyer of their animal, and to the sponsors of all other awards and prizes they received by August 15th or money will be forfeited to 4-H Council.



- d. Only purebred and breeds recognized by the American Rabbit Breeders Association are eligible to go on to the State Fair. All rabbits will be judged by the ARBA Stand ard of Perception. Crossbred rabbits are not allowed at State Fair.

- f. An automatic white ribbon is given if the dog fouls the ring. Effective 12-08-2001 the KS 4H Dog Care and Action Team approved the following disqualifications where NO RIBBON would be given for all classes of Showmanship, Obedience, and Agility. Dogs/handlers dismissed from ring by judge due to:
  - Dog leaving ring or out of control
  - Dog being overly aggressive
  - Handler using abusive language or unsportsmanlike conduct

The numbers of the five types of vegetables or fruits to be exhibited are as follows: Large Vegetables (one Each): Cabbage, Cantaloupe, Egg plant, Large Pumpkin, Squash, Watermelon Medium Vegetables (Five Each): Beets, Carrots, Cucumbers, Decorative Gourds, Potatoes, Miniature Pumpkins, Okra, Onions, Peppers, Radishes, Sweet Potatoes, Tomatoes, Garlic or other similar sized vegetables

Small Vegetables (Twelve Each): Green snap beans, wax beans, English peas, Cherry and Pear Tomatoes or other similar sized vegetables

Small fruits (one half pint box): Strawberries, blackberries, raspberries, or other similar sized fruits. Tree fruits (5 each): Apples, pears, peaches or similar sized fruits.





- For each collection class, two labels will be centered on 6. the pin beneath each specimen. First (closest to the specimen) is the common name label and the second label should include date/locality, full county name, state abbreviation. Collector's name on the date/locality label is optional.

- 4. Only specimens of class insects should be included.
- 5. Purchased insects are not to be exhibited in collections, but they may be used in educational display.

Specimens of soft bodied insects such as aphids, lice, termites, etc. should be exhibited in alcohol filled vials; however, the use of alcohol filled vials should be limited to only those specimens that lose their shape when pinned, since the vials pose a significant hazard to the rest of the collection if they become loose in transit.

4. ADVANCED ENTOMOLOGY COLLECTION Display a minimum of 150 and a maximum of 450 species representing at least 12 orders. Three standard boxes can be used. # EDUCATIONAL DISPLAY CLASSES

General Guidelines

 All entries should be submitted in an 18x24x3.5 inch wooden display box with a clear plastic top (such as plexiglass). Boxes can be handmade or purchased as long as they are of the correct size. Arrange display in the box so the box can be displayed lengthwise.

- 2. Each exhibitor is required to identify each box by placing two identification labels bearing exhibitor's name, county or district and the class in the box. Information on numbers and kinds of insects is not needed for education exhibits.
- 3. Displays may consist of specialized groups of insects or their close relatives, or relate to any aspect of their behavior, biology or ecology.
- 4. Displays should be presented in a clear, concise, and interesting manner.
- 5. Displays should include only work performed during the current year.
- 6. Title of the exhibit should be indicated inside the box.
- 7. The purpose of the project is to learn more about the importance, life cycles, biology, ecology, diversity, etc. of insects and related arthropods. Subject matter can be as varied as the animals themselves.
- 8. Creativity is encouraged!
- BEGINNING EDUCATIONAL DISPLAY Class for individuals that are exhibiting in the Beginning I and II Collection or Beginning Notebook Classes. If only exhibiting in this category, then ages 9-12. Follow the general rules listed for the Educational Displays.
- 10. **INTERMEDIATE EDUCATIONAL DISPLAY** Class for individuals that are exhibiting in the Intermediate Collection or Intermediate Notebook Classes. If only exhibiting in this category, then ages 11-14. Follow the general rules listed for the education Displays
- 11. **ADVANCED EDUCATIONAL DISPLAY** Class for individuals that exhibiting in the Advanced Collection or Advanced Notebook Classes. If only exhibiting in this category, then ages 13 or older.

- e. No live ammunition containing propellant or explosive powders may be used in any display. An inert substitution must be used in lieu of powder and "live" ammunition, the substitution must be clearly described on the back of the poster, display or in a notebook.
- f. The Kansas State Fair nor the department of 4-H Youth Development, KSRE are liable for th eloss or damage of any personal property included as part of your poster, display or notebook.
- g. Name, county or district, age and year in project should be on the front of the poster, display or notebook.
- h. Exhibit topics regarding firearm care, handling, and shooting will only be accepted from Extension Units with 4-H Certified shooting Sports Programs.
- i. Exhibits will not be accepted if they are related to reloads.
- j. Displays will be judged on the following points:

  - Interest, Holding Power 15 Does the exhibit give the observer additional facts in a clear, concise informative way?

- d. Photos must be mounted with the top edge of the print 1" below the top of the mount (board is always oriented narrow side up). The sides of the print must be equal distance from the two sides of the mount.
- e. A full coverage permanent mount (spray adhesive recommended or heat mount) must be made. Each photo is handled numerous times throughout the judging, sorting, and display process.
- f. Remove white border from the enlargement before mounting. To attach the entry form use 1" wide masking tape – fold tape around edge of mount, do not stick tape to front of mount. (Entry forms can be picked up from the Extension office).
- g. On the back of the mount, write; the exhibitor's name, photo class, and the Extension Unit (county/district). If in a district, please use full district name and add county name. Location where photo was taken.
- h. With the exception of a Photo Story Title, no lettering (this includes dates) will be permitted on the front of a mount or photo. No, under lays or borders. White strip should be removed from an enlargement. Each exhibitors name and address should be on back of the mount.
- i. Digital and/or film cameras acceptable in all categories. Photographs exhibited must be the result of the current years project work by the 4H member. Eligibility for State Fair, must follow State Fair rules.
- j. Digital Composite Image: Finished photo must be created from two or more original sources created by exhibitor. Exhibitor must include a second 11x12 1/2 matte board (Explanation Board) mounted with

### EDUCATIONAL EXHIBIT RULES

- 1. For notebooks, display boards, and posters, no additional exhibit information is required; no manila envelope is needed for these exhibits.
- 2. Exhibits are to have a clear link to the Engineering and Technology areas of astronomy, computers, rocketry, robotics, or uncrewed aerial systems, educational exhibits outside of these Engineering and Technology areas should be displayed in the other program areas. Just because an educational exhibit relates to the broad concept of Engineering and Technology does not qualify it to be displayed in the Engineering and Technology Educational Exhibit area. Exhibits that do not clearly show a clear and direct relationship to the Engineering and Technology project areas of ag-mechanics, ABC, astronomy, computers, robotics, rocketry, or UAS as previously defined will be disqualified.
- 3. Exhibits in posters, notebooks and display boards must contain substantial supporting educational materials.
- 4. Educational display boards, posters and notebooks should be creative and showcase details about the knowledge learned in the project during the current 4-H year. Value is placed on youth who can demonstrate how their skills have increased while completing the project. Each exhibit will be judged on uniqueness, creativity, neatness, accuracy of material, knowledge gained, and content. An exhibit judging score sheets available . For example, a rocket that may have crashed and/or is highly damaged may be made into an educational display or poster that tells a great story with many lessons learned.
- 5. Follow copyright laws, citing all sources of information in a standard notation Sources of information must be cited on the front of your exhibit, including all posters and educational display boards.
- 6. Educational displays are not to exceed a standard commercial 3' x 4' tri-fold display board. No card table exhibits will be allowed. Care should be taken to use durable materials that will withstand Kansas State Fair conditions.
- 7. "Construction Kits" that are part of Educational displays must be contained in cases (tackle boxes, sealable containers, etc.) that may not be larger than 1' x 2' x 2' and must have a latch which securely keeps all components contained in the "Construction Kits". Other components are to adhere to appropriate dimensions as stated elsewhere.
- 8. Educational Project notebooks must be organized in a 3-ring binder.
- 9. Any three-dimensional poster or display board exhibits may not be thicker than 2 inches.
- 10. Engines and igniters for rockets ARE NOT permitted with the exhibit and constitute an immediate disqualification. This is for safety reasons and includes both spent and live engines.
- 11. Exhibitor's name, Extension Unit, age, and year(s) in project must be tagged or labeled in a prominent location on the notebook, and/or "Construction Kit." For education displays and/or posters the exhibitor's name, county, or district, age, and year(s) in project must be tagged or labeled on the back of the exhibit. Exhibit cards are not





### For a complete set of Kansas State Fair Rules ask the Extension office for a set. NOT ALL RULES ARE PRINTED HERE.

- a. 4H member must be enrolled in rocket project.
- b. 4H member must construct own rocket.
- c. Rockets must have been flown with exception of classes 369, and 378.
- d. Rockets may or may not be exhibited on their launch pad. If exhibited without the launch pad, each rocket must be able to stand freely by itself. Rockets going to State Fair cannot be displayed on a launch pad, but can be supported on a stand or rail not to exceed an 8" square.
- e. The report that accompanies a flown rocket must include a picture of the rocket at the launch site, record of its flight, including altitude, balance, engine performance and stability and a summary of how the member constructed and flew the rocket.
- f. Engines and igniters are not permitted with the exhibit.
- g. May enter one to three rockets made during the current year.
- h. Plans (or a copy of) must accompany each rocket exhibit.
- i. Angles of the fins must fall with a plus or minus 2 degree variation.
- j. Exhibit must be uniformly painted, smoothly finished, have decal's applied smooth, and be properly assembled according to accompanying plans.
- k. Rockets with factory made fin assemblies and/or prefinished parts will not be allowed to continue on to state competition.
- If a fire burn ban is in effect for Lane County, exhibitors in Lane County are not required to launch their rocket(s). All requirements for the launching of rockets for the state fair and the documenting of the launching are suspended for the duration of the ban.
- m. If a safety violation is noted by the judges, superintendent or extension staff the exhibitor's exhibit, will be given a participation ribbon.

- g. Robots that include weaponry for the purpose of causing physical harm to another robot will be disqualified.
- h. Robots must be powered by electricity, battery, water or solar source. Any robot powered by fossil fuels or flammable liquids will be disqualified.
- i. The robot must be able to accomplish the goal the maker designed for it. Examples: Be able to vacuum the floor. Find the brightest spot in the room. Mimic life. Follow a line.
- j. Creativity will be a strong criteria in judging the robot designed by exhibitor.

#### Junior (7-13) Senior (14-18)

- 4-H members must be currently enrolled in the Kansas 4 -H STEM Ag Mechanics (welding) project to exhibit in this division.
- 2. Each exhibitor may enter one exhibit per class. Exhibits must have been constructed or repaired during the current 4-H year. The exhibit must have been selected at the county level for entry at the State Fair. Counties or district should select only top blue or purple ribbon Ag Mechanics exhibits which meet State Fair guidelines.
- 3. Wheeled exhibits must utilize a braking mechanism which prevents the exhibit from freely rolling while on display.
- 4. Exhibitors are responsible for providing sufficient braking or "chocks" for trailer exhibits to ensure that the exhibits do not move once positioned. If using a wheel "chocking" mechanism, the two individual blocks should be connected together as a pair of chocks, so they do not become separated. At least one pair of chocks should be placed on each side of the trailer to prevent movement.
- 5. For trailer exhibits the tongue of the trailer should have a locking mechanism (e.g. padlock) to prevent the trailer from being moved by unauthorized individuals while being displayed. A key for the locking mechanism should be left with the superintendent and labeled with the exhibitor's name, county, and phone number.
- 6. Each exhibit must be free-standing or sufficiently supported by an exhibitor supplied support system that is moveable and is part of the total demission's and weight of the exhibit as described previously. Exhibit boards should have a portable and moveable base and examples should be firmly affixed to the board to ensure all parts of the display stay together. No exhibits may be staked to the ground for display.
- Cutting surfaces, such as blades or knives, are to have a protective covering over them to prevent injury. The covering should be easily removed and reinstalled for judging. Foam "pool noodles" and multiple layers of cardboard are acceptable.
- 8. Display cases for small exhibits, such as knives, are acceptable, and must be easily opened so the item can be

removed and examined as part of judging.

- 9. Exhibits that include weaponry of any kind will be disqualified. Weaponry is defined as any instrument, possession, or creation, physical and/or electrical that is intended to be used to inflict damage and/or harm to individuals, animal life and/or property.
- 10. The exhibitor's name(s) and county or district must be tagged or labeled in a prominent location on the display.
- 11. Each exhibit must include an Ag Mechanics information packet. Entry of just a packet without an accompanying exhibit is not a sufficient exhibit.
- 12. Each exhibitor is required to complete the "4-H STEM Ag Mechanics Exhibit Information Form" which is available through your local K-State Research and Extension office or at www.STEM4KS.com This form must be attached to the outside of a 10"x13" manila envelope. Do not tie the envelope to the Exhibit.

# **BUILDING BLOCK ENGINEERING**

Classes (A) junior (7-13) (B) Senior (14-18)

# For a complete set of Kansas State Fair Rules ask the Extension office for a set. NOT ALL RULES ARE PRINTED HERE.

The exhibit area focuses on using architectural blocks ("Legos") to construct dioramas. This project allows youth to explore architectural design in a three-dimensional space. This division is not intended for youth wishing to exhibit constructed kits. Kits and non-diorama displays should be considered an arts and crafts exhibit, they should not be displayed in the division.

- 4-H members must be currently enrolled in the Kansas
   4-H Building Block Engineering project to exhibit in this division.
- 2. Each exhibitor may enter one exhibit. Exhibits must have been constructed during the current 4-H year. The exhibit must have been selected at the county level for entry at the State Fair. Counties or districts should select only top blue or purple ribbon exhibits which meet State Fair guidelines.
- 3. Counties are limited to FOUR exhibits to the state fair to insure sufficient space for all exhibitors.
- 4. Total exhibit dimensions may not exceed 2 feet high, by 2 feet wide, by 2 feed deep. The minimum is 6"x6"x6".
- 5. All exhibits should be placed in a sturdy see through

# FIBER ARTS—

- a. Fiber Arts is defined as any method of creating a unique design with fiber, fabric or yarn. This may include: making fabric (such as weaving crochet, knitting, needle-point): or when existing fabric is changed into something quite different (such as quilting or embroidery or ethcid art.) Ethnic Fiber Arts should use a fiber, yarn, or fabric to creat the design exhibit. Non-testile (examples include wood, reed, straw, grass, etc.) baskets/pieces should be entered in the Visual Arts Division.
- b. No exhibit will be released for any other use. State Fair fiber arts exhibits cannot be used for any of the Fashion Revue classes.
- c.
- d. When articles which are normally worn as a pair are exhibited, both articles must be shown together. Fasten articles together securely with yarn.
- e. Special consideration will be given to articles which are of original design. Such articles should have a note at-tached explaining the original design.
- f. The exhibitor may attach an index card, no larger than 4x6", with the entry form to give the judge any information which the exhibitor thinks would be helpful for the judge to know.

Explain whether you created the fabric for a knitted article by hand or by a knitting machine. Explain if the exhibit contains any recycled materials, or is made of at least 90% wool.

Fiber Arts Educational Notebook—Share with others g. what you learned in this project about a particular Fiber Art. Exhibits should be in the form of a notebook or binder. The notebook should include a narrative section describing the fiber art. It should include a clear description of the project, technique, budget, supplies, goals, accomplishments, successes, failures and future plan. It may include samples of techniques, how-tos photographs of completed projects, or other ways of educating others about fiber arts. NOTE: A collection of brochures, web pages, patterns, record book forms, etc. does not constitute an educational notebook. Follow copyright laws as explained in the General Rules as you are preparing your exhibit. Name, local unit and fiber must be clearly marked in the notebook.

#### Junior (7-13) Senior (14-18)

Classes must be designated on entry card with "**A**" for Junior or "**B**" for Senior (Example: 435A)

- a. Read general rules.
- b. All work should have been completed in the current club year.
- c. 4H members must be enrolled in the Visual Arts to exhibit in this project.
- d. Kits and originals will be judged separately.
- e. All pictures and wall hangings **must be prepared for** hanging.
- f. Entry cards need to be placed on each exhibit at the consultation judging, as well as at the fair.
- g. Consultation judging will be held on Wednesday, at 9:00 a.m. at the 4H Building.
- h. Each class may have a class champion and a reserve class champion in junior and senior divisions. Each phase such as Arts and Crafts, Leather and Ceramics may have a phase champion and reserve champion in both junior and senior divisions. An overall grand champion and reserve grand champion will be selected from the phase champions/reserve champions in the junior and senior divisions.
- i. Sketching and oil painting should be matted or framed and ready to hang.
- j. An exhibitor may enter as many exhibits per class as they want.

# CLASSES

434. Fine Arts:

Oil, chalk, charcoal, dyes, pastels, pencil, ink, acrylic, or watercolor on canvas, canvas board, paper, wood, metal, or textiles, framed as a picture, prepared for hanging, Stretched canvas art on a wooden frame is considered prepared for hanging provided that frame has a hanger.

# 435. Clay and Ceramics:

Any original item made of clay, may be fired or unfired, hand formed, or thrown on a wheel, self-hardening, fare/oven-cured, and/or cornstarch clays are acceptable, Items can include, but are not limited to, clay, statues, bowls, etc.

# 436. Leather and Jewelry:

Any leather stamping, carving, tooling, lacing, or stitching piece or any jewelry piece made from any medium are acceptable exhibits.

# 437. Three-Dimensional:

The piece must be observable on at least three sides and should be either free-standing or prepared to be hung. Craft and pre-formed or assembled projects are not acceptable.

# 438. General Crafts:

This category incorporates miscellaneous pieces that do not correspond to the four, above-mentioned categories. enclosure with a top, bottom, and 4 side. A clear tub turned upside down with exhibit place on the lid would be an acceptable enclosure. This is to keep exhibit components from being "scattered to parts unknown" at the fair. The outer dimensions of the enclosure are part of the total exhibit dimensions.

- 6. All components used in construction should be dust free, clean, free of chips, scuffs, or cracks, of hair.
- 7. The primary building component should be interlocking blocks, commonly referred to by the brand name of Lego®.
- 8. Other components can be integrated into dioramas to illustrate architectural aspects that may be difficult to convey with traditional interlocking blocks, for example marbles for small round objects.
- 9. The use of existing "store bought" sets for major elements of the display is not allowed, used of figurines from sets is allowed as are using individual bricks to create something different that the set it came from "Store bought" sets should be considered an arts and crafts entry. The intent of this is to ensure fairness among exhibitors and encourage maximum creativity instead of just following a set of plans.
- 10. The design should have a central theme, for example a garage, a house, a shop, this theme should be discussed in the video, this can link back to architectural elements in the display, for example: toilets, chairs, sofas, plants, pianos, cars, garage doors, spaceships, animals, food, etc. (architectural elements, components, and features can be thought of as nouns)
- 11. Displays must have significant **architectural components.** Examples of architectural components include walls, windows, doors, roofs, canopies, flying buttresses, etc.
- 12. Landscapes are strongly discouraged, however buildings can have a reasonable exterior landscape if it clearly linked to the architecture, for example a bike rack next to a street outside of a bicycle shop.
- 13. Architectural components should have a consistent look, walls and roofs that have no pattern or consistency will be deducted one ribbon placing.
- 14. Gaps or cracks should not be visible between assembled blocks.
- 15. Doors should open and close, large doors can be fixed in either an open or closed position, but it should be obvious that it is a large door, windows can be either fixed or open and close.
- 16. Vehicles that are intended to stay in a single place should be affixed to base plates with sticky tack, hot glue, or other method.
- 17. You can use a partial wall or no wall, called a reveal, to show what is happening inside of a structure are acceptable, for example only having three walls to allow an unobstructed view into a room.
- 18. Mechanical enhancements or motion elements that add motion to the diorama are acceptable and encouraged. For example, marry-go-rounds, doors, elevators, gears, marbles going down a channel, flapping wings, animatronics, etc. If included judges should be able to use them and instructions should be provide for operation either in

the story or on a separate page.

- Artistic designs with no architectural design/ components are not permitted and two ribbon placings will be deducted, these exhibits should be displayed in arts and crafts.
- 20. The exhibitor's name(s) and county or district must be tagged or labeled in a prominent location on the display, additionally the display case should have the exhibitor's information attached to it as well, as the top part of the case may be separated from the display.
- 21. Each exhibit must include an information packet. Entry of just a packet without an accompanying exhibit is not a sufficient exhibit.
- 22. Each exhibitor is required to compete the "4-H Building Block Engineering exhibit Information Form" which is available through your local Extension office or at www.STEM4KS.com. This form must be attached to the outside of a 10"x13" manila envelope. Do not tie the envelope to the exhibit. Form must be current and include all items listed on form.
- 1-5 pages of photos showing work on the exhibit, preferably from a beginning state to final or completed state, these help in determining where a part might go in case something comes loose.
- If appropriate operating instructions for mechanical portions of the diorama.
- 23. Additionally, at state fair level, exhibitors are required to create a video about their project discussing their construction experiences and the architectural elements of the diorama (tell the story of what is happening in their exhibit). This allows judges to get a better understanding of the exhibit and allows you the opportunity to fully explain their exhibit. The video should be no longer than 8 minutes and should be placed on a USB drive. These videos may also be considered for inclusion in a running video loop in the STEM area at the state fair after review by judges, superintendent(s), and extension staff. Adult guardians must complete the video release included with the exhibit form. If the release is not completed the video will not be included in the video loop on display in this area at the Kansas State Fair.
- 24. Each exhibit must be accompanied by a 4-H Engineer Form.

- b. The Lapidary classes will be judged on the following criteria:

Specimens should be arrangedacross the (18") dimension of the exhibit box, makingthe exhibit 18" across the top and 12" deep.

## CLASSES

- 5300. Display at least 5 varieties of polished (tumbled) specimens and 5 varieties of unpolished specimens that have not yet received lapidary treatment. These do not have to be an example of "before and after", nor do they have to be self-collected. Locales must be identified. Only those exhibiting lapidary at the State Fair for the first time may exhibit in this class.
- 5301. Display before-and-after examples of at least 3 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. There is o requirement that the 4 -H'er collect any of these. Locales must be identified. Lapidary work should be done during the current 4-H year.
- 5302. Display before-and-after examples of at least 6 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. At least two varieties should be collected from the native site by the 4l-H'er, at least one of which comes from Kansas. Locales must be identified. Lapidary work on at least three varieties should be done during the current 4-H year.
- 5303.Display before-and-after examples of at least 9 varieties of specimens, at least 2 tumble-polished and 2 unpolished of each. At least three varieties should be collected from the native site by the 4-H'er, at least two of which comes from Kansas. Locales must be identified. Lapidary work on at leas three varieties should be done during the current 4-H year.
- 5304.Exhibit at least 6 specimens that have not previously been exhibited, which have received lapidary treatment. Lapidary treatment may consist of polishing, and end, face, or flat lapping. Specimens must represent at least 3 different varieties and include at least three cabochons of any size of shape, only one of which may be free-formed. A cabochon is a style of

- g. For the geology classes (406-408) all specimens must be collected from locations in Kansas. Out-of-state specimens will not count in the minimum number for the class, nor will they be considered in the judging. Boxes with glass covers will not be accepted at State Fair. Plexiglas covered wooden boxes are required.
- h. The overall grand champion will receive a prize.

# Geology

- a. Display at least 15 rocks, minerals and fossils collected the current 4H year. Limited to one exhibit box 18"x24"x3 ½" with Plexiglas cover. This class is open to those exhibiting first or second time at the State Fair. Fossils must be identified to the phylum level.
- b. Display at least 30 rocks, minerals and fossils at least 5 of each. Fifteen must be collected during the current 4H year. Limited to one exhibit box 18"x24"x3 ½" with Plexiglas cover. This class is open to those exhibiting eitherfirst or second time at the State Fair. Fossils must be identified to the Phylum level.

- c. Display at least 45 rocks, minerals, or fossils, at least 5 of each. More than one specimen of the same kind of rock or mineral or species of fossil may be exhibited if this duplication represents different geological formations. Specimen label must show this distinction. (Fort Hays limestone not just limestone; exact species must have different formation names listed on the I.D. card: Composita Brachiopda from Morrill limestone not just Brachiopoda or Composite Brachiopoda). Exhibit limited to two boxes 18"x24"x3 ½" with Plexiglas cover. Exhibit must include approximately 15 specimens of current year's work. Rocks must be identified by their proper name and type. Fossils must be identified to the Phylum level. This class is open to those exhibiting either the third or fourth time at State Fair.
- d. Display at least 60 rocks, minerals, or fossils at least 5 of each. More than one specimen of the same kind of rock or mineral or species of fossil may be exhibited if this duplication represents different geological formations. Specimen label must show this distinction (Fort Hays limestone not just limestone; exact species must have different formation names listed on the I.D. card: Composia Brachiopoda from Morrill Limestone not just Brachiopoda or Compostia Brachiopoda). Exhibit limited to two boxes 18"x24"x 3 <sup>1</sup>/<sub>2</sub>" with plexiglass cover. Exhibit must include approximately 15 specimens of current year's work. Rocks must be identified by their proper name and type. Fossil must be identified to the Phylum, class and genus levels if possible. This class is open to those exhibiting the fifth time or more at the State

open to those exhibiting the fifth time or more at the State Fair.
e. Special exhibit relating to every day living; or to a mineral test a rock formation geological history species of a fos-

# ASTRONOMY Junior (7-13) Senior (14-18)

The exhibit area is designed to provide youth the opportunity to explore space through telescopes, research, and observation.

- 1. The 4-H member must be currently enrolled in the 4-H Astronomy project to exhibit in this division.
- 2. Each exhibitor may enter one exhibit per class.
- 3. Telescopes entered in this division may be built from a kit or by original design. Pre-finished telescopes, which require no construction or painting are not acceptable exhibits.
- 4. Telescopes are limited to no more than six feet in length. They must be placed on a stationary stand that does not allow the telescope to roll and/or fall over. The stand cannot extend past two feet in length or width.

#### **CLASSES:**

- 1. Telescope made from kit.
- 2. Telescope made from original design.

ELECTRIC & RENEWABLE ENERGY—Hunter & Stephen Riffle

- a. Read general rules.
- b. Only those who have met the requirements of the energy management project are eligible to exhibit in this division.
- c. Articles that have been in use should be cleaned for exhibit.
- d. A sheet of operating instructions must be furnished for any exhibit not self-explanatory.
- e. Project (classes 4600, 4601 and 4602) must be operable using only 110 or 120V AC or battery power. If battery power is required, batteries must be furnished.
- f. Any project with a complexity of size or electronics must have (1) instruction for assembly and use (2) equipment available at the time of judging for actually testing of the exhibit.
- g. No hand dipped solder may be used on exhibits.

#### **Electrical and Electronics**

4600. AC Electric. Electric projects with a 110 or 120 V alternating current (AC) power source. Some project examples are household wiring demonstrations, small appliances extension cords, trouble lights, indoor or outdoor wiring boards, or shop lights. Projects may be a restoration or original construction. The project must be operational and meet minimum safety standards. AC projects must be 110/120 V, no 240V exhibits are allowed, and must be constructed such that the judges have access to examine the quality of workmanship.

- 4601. DC Electric. Electric projects with a battery or direct current power source. This class includes electric kits or original projects. This class also includes demonstration DC powered project. Examples include: wiring two or three way switches, difference between series/ parallel lighting circuits or wiring doorbells switches. All DC electric projects must work with batteries supplied by 4-H'er. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.
- 4602. Electronics. Electronic projects with a battery or direct current power source. This class includes electronic kits or original projects. Examples Include radios, telephones, toy robots, light meters, security systems, etc. May be constructed using printed circuit board, wire wrap, or breadboard techniques. Include instruction/ assembly manual if from a kit. Include plans if an original project. Projects must be constructed such that the judges have access to examine the quality of wiring workmanship.
- 4603. Educational Displays and Exhibits. The purpose of the educational display and exhibit is to educate the viewer about a specific area of the 4-H electrical or electronics project. The display or exhibit should illustrate one basic idea. This class includes any educational displays, exhibits or science fair type projects which DO NOT have a power source, i.e. exhibits, posters or displays of wire types, conduit types, electrical safety, tool or motor parts identification or electrical terminology. Educational displays and exhibits must be legible from a distance of four feet, using a maximum tri-fold size of 3'x4'.

#### ALTERNATIVE ENERGY

#### Junior (7-13) Senior (14-18)

Classes must be designated on entry card "A" for Junior and "B" for Senior. (Example: 4620B)

**Alternative ENERGY** (A form of energy derived from a natural source, such as the sun, geothermal, wind, tides or waves) All exhibits in this division are limited in size to standard, trifold, display boards (36"x48") and items may not extend beyond 12" from the back board. All displays must be self-standing.

- 4620: **EDUCATIONAL DISPLAY**—Create an exhibit that addresses a focused topic related to power generated from a renewable energy source. The purpose of the exhibit is to inform and create awareness
- 4621: **EXPERIMENT**—Display an experiment addressing a problem or question related to power generated from a renewable energy source. Include hypothesis, back-ground research, variables, a control, data, findings, conclusions and recommendations for future study.

#### WOODWORKING -

#### Junior (7-13) Senior (14-18)

Classes must be designated on entry card with a "A" for Junior or "B" Senior. (Example: 408A)

- a. Read general rules.
- b. Designate on entry if article is original or kit construction.
- c. The plan from which it is constructed must be with the article exhibited. Enclosed in Ziploc bag, tied /secured to project.
- d. Plan must be complete and accurate, either by scale drawing or fully dimensioned to the extent that a duplicate article could be built using the plan as a guide. CLASSES
- 420. Article for farm or shop use.
- 421. Furniture for household or lawn use.
- 422. Other woodwork. Articles not included in above classes including any article made from a kit. Examples: bird house, bird feeder, household equipment such as knife racks, bread boards, door stops, etc.

GEOLOGY – Glenn Roberts

#### Junior (7-13)

#### Senior (14-18)

Classes must be designated on entry card with a "**A**" for Junior or "**B**" Senior. (Example: 416A)

- a. Read general rules.
- b. Specimens must be collected by exhibitor.
- c. Exhibit may contain:
  - (a) Fossil, minerals or rocks
  - (b) Combination of the above label
  - (c) Name, fossils, mineral or rock
  - (d) Location where item was found
  - (e) Date collected
- d. The standard size exhibit box should be 18"x24"x3 ½". All specimens are to be arranged across the narrow (18") dimension of the exhibit box, making 18" across the top and 24" deep. If a box has a sliding Plexiglas cover, it must be removable from the top. Screw, locks or other devices that would prevent judges from removing cover should not be used. Each exhibitor is required to identify each display box by placing an identification label bearing name, county and number of specimens in the upper left-hand corner of the cover (inside), and by attaching a label with the same information to the back of the box.
- e. Exhibitor may enter in both geology and lapidary classes. Exhibitor may show in only one of the first three geology classes (406-408). Exhibitor may also show in geology class 4 (special exhibit) and in the lapidary class.
- f. Geology specimens should be labeled with the number of the specimens, date collected, specimen name, or description and locality (county) where collected. For the geology classes (406-408) specimens should be mounted in the box by proper groups – rock, minerals and fossils.

# Junior (7-13) Senior (14-18)

Classes must be designated on entry card "**A**" for Junior or "**B**" for Senior. (Example: 407A)

All exhibits should involve engines smaller than 20 horsepower for classes 407-409. Displays are limited to 4' wide and 4' deep—both upright and floor displays.

- a. Only those who have met the requirements of the small engine project are eligible to exhibit in this division.
- b. An exhibitor may enter up to three items in this division, bt only one article per class. Use the entry card available from your Extension Office. Record all requested information and securely attach to exhibit.
- c. Items that have been in use should be cleaned for exhibit.

# CLASSES

- 4610. DISPLAY—Exhibit a display, selecting one of the following options: 1) a display identifying different engine or lawn and garden equipment parts or a display showing the function of the various engine or lawn and garden equipment parts; OR 2) a display identifying and explaining the function(s) of different special tools needed for small engine work ; OR 3) a display illustrating and providing the results of any one of experiments that are included in the project books. No complete engines, lawn tractors, tillers, chainsaws are permitted for display. Maximum tri-fold size is 3' x 4'.
- 4611. MAINTENANCE—Exhibit a display that illustrates either 1) Routine maintenance procedures OR 2) Diagnosing and trouble shooting specific problems in an engine. No complete engines, lawn tractors, tillers, chainsaws, etc are permitted for display, using a maximum tri-fold size of 3' x 4'.
- 4612. OPERATION—Exhibit an operable small engine (no more than 20 HP) overhauled or rebuilt by the member. Include maintenance schedule for the engine and a brief description of steps taken by the member overhauling or rebuilding the engine. Maximum tri-fold size is 3' x 4'.

- 1. Any item which **IS NOT** a notebook, display board, or poster displayed in this class is considered a "computer system" exhibit and <u>MUST</u> follow the rules set forth below.
- 2. The actual construction of computer hardware (i.e., building a computer, electronic devices with a motherboard-based manipulation) will remain in the Energy Management division.
- 3. 4-H members must be currently enrolled in the 4-H STEM—Computers project to exhibit in this division.
- 4. Each exhibitor may enter one exhibit per class.
- 5. Physical computers such as tablets, smart phones, laptops, or personal computers (PCs) will not be accepted as an exhibit.
- 6. All exhibits must be:

A. Self-contained on a USB drive (thumb drive, flash drive, jump drive, or other any other name for a small USB storage device; the rules will use "USB drive").
B. OR System-On-a-Chip (SOC) (such as Raspberry PI) or a Micro-Controller (such as an Arduino or Ozobot) AND is a compact (less than 8"x8"x8") system, which can be programmed AND requires minimal assembly to operate (e.g. connecting power, display, and keyboard/mouse cables).

7. Each exhibit must be accompanied by a "4-H Engineer's Journal." The engineer 's journal should be typed. It can either be included electronically on the USB drive (preferred) or printed and placed in the manila envelope.

#### **Computer System Division Classes**

- 5590 Computer program, application, app, script, or coded system that is new and unique (not merely a file run in a program, such as a 'word document' or a picture drawn in "Microsoft Paint").
- 5591 Computer presentation (power point< web page/site, animated graphics such as gifs, etc.)
- 5592 Single computer system (web server, database server, etc.) represented as a virtual machine.
- 5593 Networked system consisting of two or more virtual machines.
- 5594 Chip system—a small (8"x8"x8")programmed physical device that accomplished a specific task.
